## **MEMORANDUM OF COOPERATION**

### **Subject**

#### **Article 1**

(1) This Memorandum of cooperation (here and after: MoU) regulates the cooperation between the Iustinianus Primus Law Faculty in Skopje and Faculty of Law, University in Priština-Kosovska Mitrovica in relation to the exchange of experiences, knowledge, education, literature and training of personnel in areas in which both parties have interest.

(2) The cooperation from paragraph 1 of this article will be conducted in accordance with the Law on Higher Education, bylaws of the Iustinianus Primus Law Faculty and the Law on Higher Education, bylaws of the Faculty of Law, University in Priština-Kosovska Mitrovica, as well as other laws and bylaws of the Republic of North Macedonia and the Republic of Serbia.

### **Types of cooperation**

#### **Article 2**

(1) Iustinianus Primus Law Faculty in Skopje and Faculty of Law, University in

Priština-Kosovska Mitrovica will cooperate in the area of education, training, publishing of expert and scientific articles, expert assistance in developing projects, analyses and other forms of transfer of know-how and experiences in joint research and development;

(2) Iustinianus Primus Law Faculty in Skopje and Faculty of Law, University in Priština-Kosovska Mitrovica, depending on the mutual interest, will cooperate in the development of joint research projects and provide mutual support in organization of workshops, scientific gatherings, roundtables and other types of events;

(3) Iustinianus Primus Law Faculty in Skopje is open for cooperation, providing expert and scientific opinions and consultations in relation to training and transfer of know-how to the personnel employed by Faculty of Law, University in Priština-Kosovska Mitrovica.

(4) Faculty of Law, University in Priština-Kosovska Mitrovica agrees to provide educational and expert training of students enrolled at the undergraduate and postgraduate level at the Iustinianus Primus Law Faculty in Skopje;

## **COOPERATION**

### **Article 3**

The cooperation from article 2 of this MoU will be executed upon request for each type of cooperation specifically, for which a separate program and budget will be additionally agreed by both parties.

## **Final provisions**

### **Article 4**

(1) This MoU shall enter into force upon its signing by the parties.

(2) Any amendments to this MoU shall be made in writing and signed by the parties to take effect.

(3) Any disputes related to and arising from this MoU shall be settled in amicable matter.

(4) The MoU is composed in 4 identical copies, out of which 2 are for the Iustinianus Primus Law Faculty in Skopje and 2 are for Faculty of Law, University in Priština-Kosovska Mitrovica.

(5) The Annex of the MoU contains the contact details of persons responsible for cooperation. For any amendments in this Annex the parties shall notify each other in writing.
